#### Introduction



In fulfillment of the ESIA Process Bea Mountain Mining Corporation (BMMC), Submitted a Notice of Intent in November 2023 and an ESIA & RAP on February 27, 2024; for the acquisition of an Environmental permit to commence mining at the Matambo Gold mine, in Grand Cape Mount County. The Stakeholder Meeting, to discuss the initiation of open pit mining in the Matambo Corridor of the Bea Mountain Mining Concession and the relocation of Bangoma Town, faced a delay on April 25, 2024. The Project Affected Communities (PACs) raised certain disagreements and demanded the presence of their elected representative in the House of Representatives, Hon. Gbessay Sonni, before any meeting involving BMMC could take place. As a result of the PACs proposal, the stakeholder meeting was rescheduled for May 4, 2024, in Bangoma Town, Tewor District, Grand Cape Mount County.

#### Introduction



- The second phase of the stakeholders Consultation brought together Two Lawmakers, Hon. (Ma) Gbessay Sonii, and Hon. Mohammed Doesee, of the Grand Cape Mount Legislative Caucus, representatives of the Project Affected Communities, Ministries, Agencies and Commissions of Government, Civil Society Organizations, representatives of Bea Mountain Mining Corporation, persons of interest, Petra Resources, Inc., and technicians from the EPA
- Note: The Agenda of the Meeting was suspended due to intermittent interruption about the purpose and clarity of the meeting by the Law makers in attendance

#### Conclusion



The Stakeholder Meeting for the Matambo corridor including relocation of Bangorma Town was not held for the second time in succession due to contentions raised by the people of the projected affected towns and their elected Lawmakers, Hon Sonni and Hon Dosee. The lawmakers along with their citizens demanded that BMMC must discuss and settle with them all issues relative to the operations of the company in their district before proceeding to the stakeholders Consultation to discuss the ESIA report. The meeting was postponed by the EPA, thereby mandating the need for BMMC to resolve issues with the Legislative Caucus, meanwhile an official communication from EPA on the way forward will be transmitted to BMMC in keeping with the EPML.

#### Recommendation



- BMMC to reengage with the Legislative Caucus on pending matters for which it has been summon for:
- EPA to juxtapose or evaluate the RAP along with findings from the engagement process at Matambo, and invite BMMC on the way forward to include the following:
- There is a need to ensure update or redesign of the RAP, conduct verification, validation, and approval.
- Issues with bridge relative to the FPIC process, development and signing of MOU by all PAPs needs to be address.
- Relocation issues needs to be reconsidered as part of the RAP to ensure all new structures meets MPW standard and international best practice to improve the living condition of the people
- Issues of sacred sites or graves which are part of the traditional practice of the people needs to be captured within the RAP for the relocation process.
- All issues of crop compensation should meet the standard of the MoA and international Best Practice.



It is of paramount importance that we establish whether this suspension of operations is a temporary measure or a permanent cessation. A formal and official confirmation of the company's long-term intentions will provide the necessary information for our constituents. Should the suspension be permanent, it is vital for our people to be allowed to re-apply for licenses and return to their customary mining practices

In light of this, I propose the following actions:

- Initiate an immediate parliamentary inquiry to determine the operational status and future plans of BEA Mountain Mining Corporation in the Matambo comdor.
- Ensure prompt and transparent communication of the findings from this inquiry to the affected community members.
- If it is found that BEA Mountain has ceased operation permariently in this comdor, provide support and facilitate the expedited processing of mining activities.

This decisive action will not only alleviate the current state of uncertainty, but also uphold the economic stability and legacy of our district.
