The Deputy Head of the Secretariat, Zaza Y. Quaqua, welcomed the CSOs to the LEITI Secretariat and encouraged them to deliberate on the workplan (2024/2025) freely.

As the different CSO representatives deliberated, the following points were taken:

- ✓ CSOs should use information from the LEITI freely; There should be no MOU for that. This will help promote Contract Transparency in the Country.
- ✓ CSOs must be trained by the LEITI Secretariat on the scope of the EITI to help expand.
- ✓ LEITI should compile a list of non-compliant companies and share it with relevant CSOs during its reporting processes;
- ✓ LEITI must coordinate efforts to regulate and formalize the Artisanal Mining Sector to help the Government's revenue generation.
- ✓ When concessions are signed, obtain copies from the Legislature and the Executive.

As the different GOL Ministry and Agencies representatives deliberated, the following points were taken:

- ✓ Work with CSOs to disseminate LEITI's reports LACC
- ✓ An MOU should be forged with the FIA to investigate further issues of money laundering and other financial crimes that may arise from the LEITI Reports.
- ✓ Government institutions should carry one or two LEITI staff alone whenever they engage in rural areas to help disseminate LEITI reports.
- ✓ OGP is willing to work with LEITI to disseminate LEITI's reports.
- ✓ Local authorities should form an integral part of the LEITI dissemination exercises.
- ✓ LEITI should Continue to budget for vehicles until it gets it GAC
- ✓ Consistently discuss LEITI underfunding on the media.
